



Rules & Regulations

Rules Subject to change

- RV & boat storage is not permitted.
- Use of screws and nails is not permitted in trees or park property.
- Use of pallets or scrap lumber for firewood is not permitted.
- Laundry room hours are from 7:00am-10:00pm.
- All persons must comply with Federal, State & Local laws.
- Payment must be on time and in advance of the 12:00 Noon check out time.
- The park expressly prohibits the use of campsites without payments.
- Quiet hours are from 10 PM to 7 AM.
- Campsites are designated to hold a maximum of six (6) family members.
- Campfires, if conditions allow, in fire rings only.
- Additional camping units and vehicles will require an additional campsite and/or fee.
- Persons under 21 years of age must be accompanied by an adult.
- Parents are responsible for the conduct of their children.
- Inform park supervisor if you plan to be away from your campsite overnight.
- No washing dishes or laundry in the bathrooms.
- No washing or repairing vehicles in the camp ground.
- Transporting of black/grey water is prohibited except in an approved container. Please use dump station for disposal.
- Line/rope is not permitted to be tied to trees.
- Fireworks and Alcoholic Beverages are prohibited in the Park.
- There is a limit of two pets per campsite. Pet owners must show proof of proper vaccinations and licenses. Pets must be kept on campsite or pet walk areas at all times and be restrained with a leash six feet or less. Pet waste and leash laws enforced.

The front gate is closed
and locked at 7:30PM.

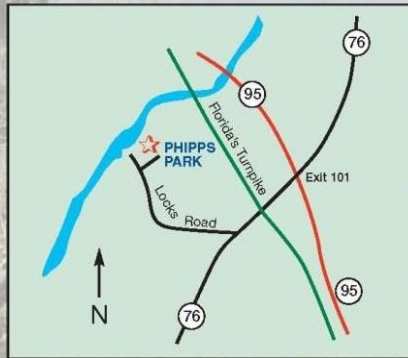
To open the lock:

1. Line up the combination numbers on the bottom of the lock.
2. Press in the shackle, then pull out and the lock will open.

To close the lock:

1. Press in the shackle, then spin the numbers on the lock.
2. Please check to be sure the lock is locked.

combination during office hours.
