# Governor DeSantis' Florida Leads Budget Highlights:

# **Environmental Resources**

- Water Quality Enhancement and Accountability \$10,802,386 Funds provided to improve water quality throughout the state including recommendations made by the Blue Green Algae Task Force, increased monitoring, data collection efforts, and analyses. Funds shall also be used to maintain and further develop the water quality public information portal, analytics, and to support the Blue-Green Algae Task Force.
- Grants and Aids to Local Governments and Non State Entities Innovative Technology from Land Acquisition Trust Fund - \$10,000,000
   Funds provided to the Department of Environmental Protection for the purpose of supporting the evaluation and implementation of innovative technologies and short-term solutions to combat or clean up harmful algal blooms and nutrient enrichment of Florida's fresh water bodies, including lakes, rivers, estuaries and canals. This program supports the efforts of the Blue-Green Algae Task Force consensus findings to address nutrient loads to impaired waterbodies affected by blue-green algae. Funds may be used for the Department's red tide emergency grant program to support local governments in cleaning beaches and coastal areas to minimize the impacts of red tide to residents and visitors. Funds may also be used to implement water quality treatment technologies, identified by the Department, near water control structures in Lake Okeechobee.
- Grants and Aids to Local Governments and Non State Entities Water Quality Improvements - Everglades Restoration from Land Acquisition Trust Fund -\$50,000,000

Funds shall be distributed to the South Florida Water Management District for the design, engineering, and construction of the specific project components designed to achieve the greatest reductions in harmful discharges to the Caloosahatchee and St. Lucie Estuaries as identified in the Comprehensive Everglades Restoration Plan Lake Okeechobee Watershed Restoration Project Draft Integrated Project Implementation Report and Environmental Impact Statement dated July 2018.

• Total Maximum Daily Loads from Land Acquisition Trust Fund - \$45,000,000

Funds are provided to monitor and assess water quality, set scientific water quality restoration goals (Total Maximum Daily Loads), and accelerate the implementation of the projects and actions set forth in restoration plans, such as Basin Management Action Plans (BMAPs) to address nutrient pollution, including green infrastructure and land acquisition projects. This program supports the efforts of the Blue-Green Algae Task Force consensus findings to address nutrient loads to impaired waterbodies affected by blue-green algae.

Beach Funding: Senator Hutson - SB 1240

This bill doubles the funding for the statewide beach program to \$100M, or funds the entire approved list, whichever is lesser.

# **Transportation & Economic Development**

Governor DeSantis' *Florida Leads* budget provides significant funding for economic expansion and transportation infrastructure.

# Transportation and Infrastructure

- **\$9.47 billion** for the State Transportation Work Program
- \$423.3 million for workforce and affordable housing programs across the state to help working families meet basic housing needs. This funding is in addition to the more than \$250 million to address affordable housing needs and the increase in homelessness due to the economic downturn caused by COVID-19.

# **Economic Development**

- **\$50 million** for the Job Growth Grant Fund to support local infrastructure and job training projects targeted towards economic recovery and development
- **\$5 million** for Enterprise Florida, Inc. to engage in targeted marketing campaigns
- **\$50 million** for VISIT FLORIDA's marketing programs (the same amount as in the current fiscal year)
- **\$50 million** for the Economic Development Transportation Fund, also known as the "Road Fund"

# Education

- **\$22.8 billion** in total funding for the Florida Educational Finance Program (FEFP)
  - Highlights of the FEFP Increases include:
    - \$550 million to continue raising the minimum teacher salary to \$47,500 as well as other instructional personnel;
    - \$110 million for mental health programs and initiatives;
    - \$59.7 million for compression funding;
    - \$43.5 million for Title I School Recognition

- **\$39.2 million** for school safety grants provided to school districts to assists with costs associated with improving the physical security of K-12 school buildings
  - \$1 million for the Coach Aaron Feis Guardian Program
- Maintenance
  - **\$112 million** for traditional public school and Florida College System maintenance;
  - **\$180 million** for public charter school maintenance;
  - **\$7.6 million** for lab school maintenance;
  - **\$2.7 million** for Florida School for the Deaf and the Blind maintenance;
  - **\$5.9 million** for public broadcasting stations to correct health and safety issues, correct building deficiencies and other project renovations;
