## **Budget and Septic to Sewer Conversion**

The respective house and senate subcommittee chairs rolled out their budget recommendations which included major cuts across all budget silos. These plans do not include federal funding for Florida from the American Rescue Plan and the new state general revenue estimates. Each chamber will be taking up their General Appropriations bill next week with floor action during the week of April 5. Included in the Senate offer is a placeholder allocation of \$250,000 for the Martin County Port Salerno/New Monrovia Vacuum Sewer System.

Proposed Budget Highlights include:

- \$26 million for the Job Growth Grant Fund
- \$50 million for VISIT Florida
- \$99.1 million for State Housing Initiative Partnership (SHIP)
- Over \$280 million for the Comprehensive Everglades Restoration Plan
- \$25 million for alternative water supply projects
- \$20 million for Resilient Florida Planning Grants
- Over \$140 million for wastewater grants
- \$10 million for innovative technologies related to water quality projects
- \$10 million for the Blue Green Algae Task Force
- \$50 million for Florida's beaches

The budget will be workshopped through the rest of session as the senate and the house need to agree on funding for each line item. Funding is subject to change until final passage of the budget bill at the close of the legislative session.

# Restructured Distribution of Doc Stamp Revenue

The Florida House of Representatives Speaker Chris Sprowls and Senate President Wilton Simpson announced their plan to fund key infrastructure programs by restructuring the distribution of documentary stamp tax dollars currently allocated for the Sadowski Trust Fund.

Under the three-part infrastructure plan, one-third of the existing distribution to the Sadowski Trust Fund would be directed to the Always Ready: Flooding and

Sea Level Rise Agenda, highlighted by Speaker Sprowls and House members during a February news conference. One-third would be directed to the Wastewater Grant Program within the Department of Environmental Protection, a priority of Senate President Simpson, established by Senate Bill 712 (2020). One-third would continue to be distributed to state and local affordable housing programs, with language that prevents these distributions from being swept to general revenue. This plan will allow funds for all three infrastructure priorities to grow at a consistent and predictable rate.

## HB 0001 Combating Public Disorder by Fernandez-Barquin

Combating Public Disorder: Authorizes elected officials to file appeal to Administration Commission if municipality makes reduction to budget of municipal law enforcement agency; provides for cause of action against municipality for failing to provide law enforcement protection during riot; revises penalties for certain riot related offenses; prohibits cyberintimidation by publication; prohibits specified assemblies from engaging in disorderly & violent conduct; creates affirmative defense to civil action where plaintiff participated in riot or unlawful assembly. Effective Date: upon becoming a law
