

Brightline Construction Advisory Lane Closure and Work Zone Updates for Orlando Extension (Phase 2 - South Florida to Orlando)

ORLANDO, FI. (October 11, 2021) – Brightline announces lane closures, work zone, railroad crossing and bridge work information for Phase 2 construction from Orlando to West Palm Beach, connecting Orlando to South Florida. Motorists and watercraft should proceed with extra caution through work zones and adhere to posted detour signs, speed limits and other signage.
