






Martin Cases by Month, 2021-2022




Martin Monthly Cases by Age Group, 2021-2022




Martin Monthly Percentage of Cases by Age Group, 2021-2022




Martin Monthly Cases by Age Group, Nov 2021-Feb 2022



Martin Cases by Age 0-18yo, Nov 2021-Feb 2022




Martin Weekly Cases by Age Groups 5-18
