The applicant further agrees to indemnify, save harmless and defend the County, its agents, servants and employees from and against any claims, demands, or causes of action of whatsoever kind or nature arising out of any conduct or misconduct of the applicant not included in the paragraph above and for which the County, its agent, servants, or employees are alleged to be liable.

The applicant agrees to immediately pay the County for any services provided by the County at its usual rates. The Martin County Film Commission will provide coordination and advise the applicant of estimated costs.
