

Message from the CRA Chair

Our Martin County CRA communities are under construction! FY 2021 saw the completion of two long anticipated, game-changing projects, Mapp Road Town Center in the Old Palm City CRA and Bridge Road Main Street in the Hobe Sound CRA. These transformative streetscapes checked many community development boxes - new and improved infrastructure and roadway design; enhanced vehicular and pedestrian safety; generous, connected sidewalks; increased on street parking; decorative lighting and lush landscaping. All of these elements promote business development, enhance corridor walkability and assist in future parcel redevelopment and expansion in the center of these CRA areas.

In fact, our CRA areas are enjoying the benefits of transformative construction projects all over the county. Pettway Village, an affordable housing project in the Hobe Sound CRA; Dixie Highway roadway enhancement in the Golden Gate CRA; water infrastructure installation in the Port Salerno CRA; sewers replacing septic tanks in the Rio CRA and the "out-of-the-box" Ripple Stormwater Eco-Art project in the Old Palm City CRA, the first of its kind ever done in Martin County.

As we celebrate these achievements, there is also an opportunity to take stock. Martin County is halfway through its CRA journey. We are determined to continue to pursue infrastructure installation and project construction to fulfill our Community Redevelopment Plans. As our visions become realities, these new places and spaces will need activation for our residents and visitors to keep them vital and productive.



Bridge Road Main Street

The Hobe Sound community has envisioned a Main Street that promotes business and economic development for 20 years! This project provides increased parking, quality pedestrian facilities, improved safety, underground utilities, new water mains and enhanced corridor walkability with continuous sidewalks, raised crosswalks, lighting and landscaping. Many thanks to the generosity and forward thinking of the Bridge Road property owners for donating pieces of their property to make this project possible. Bridge Road is also sporting a brand new, one of a kind, over the street banner system to advertise community events. The project has been funded through debt service and TIF funds.

Sound Brewery, the first micro brewery in any CRA in Martin County


Mapp Road **Town Center**

The Old Palm City Mapp Road Town Center vision has finally come to life showcasing generous sidewalks, landscaping, decorative streetlights, trash/recycling receptacles, curb and gutter drainage and on street parking - a well-connected corridor that safely accommodates vehicles, bicycles and people. Funded through a variety of sources including debt service and TIF funds, Mapp Road Town Center began inauspiciously with a virtual groundbreaking during COVID, done alone by District 5 Commissioner Edward V. Ciampi. On August 28, 2021, the Ribbon Cutting event - consisting of 20 local business booths, boy scouts, the Humane Society, 200 residents, food trucks, an antique car show and more - tells the real story!

Ripple Stormwater Eco-Art Project

"Ripple...as a drop of water becomes a river" is a unique combination of stormwater treatment, artistic elements and community engagement. The Ripple project reconnects the Old Palm City neighborhood with the St. Lucie River at four distinct sites using a series of artist designed elements. The county, professional engineers, landscape architects and the artist, Lucy Keshavarz, have engaged the community and received significant citizen input to inspire the design for these new stormwater treatment areas.

The project is funded by TIF dollars enhanced by two National Endowment for the Arts grants and two Department of Environmental Protection grants. This stormwater treatment project, integrated with artistic and educational elements, will not only enhance and beautify our community, but will be an environmental asset as well.

IN THE PIPELINE:

Art elements to be constructed with Ipe wood, coquina rock and enhanced with educational message boards










Palm City Place and Patio

Palm City Place will serve as a passive park, with a walking trail, benches, trees and a fishing pier for the community. The walking trail began in 2021 is now complete thanks to the Martin County Public Works Department. The "Patio" is the small pie wedge-shaped piece that sits right on the brand new 20-foot sidewalk along Mapp Road. This community gathering space will include an event pavilion, lush landscaping, tables, benches, ping pong, chess and cornhole. The project is funded through a Land and Water Conservation Fund grant through the Florida Department of Environmental Protection, with the match supported by the District 5 Commissioner, Edward V. Ciampi.


Infrastructure

Rio Infill Sewer Installation

Infrastructure is part of all six Community Redevelopment Plans in the Martin County CRA. It started in Rio with CDBG funds some 10+ years ago. Fast forward to 2021 and the Martin County Utilities Department's "Connect to Protect" program. This grinder installation program is a one stop shop which also offers approved contractors and payment options, allowing customers to hook up quickly and easily. The Rio CRA area is utilizing their TIF funds to design and install a total of 656 grinder stations. Construction began in FY 2021 and will continue through FY 2023.

IN THE PIPELINE:

The entire Rio CRA will have access to water and sewer



Port Salerno Water Installation

In Port Salerno, there are many neighborhoods and households still using septic tanks and wells. Without basic infrastructure, redevelopment is more challenging, so the Port Salerno CRA has been focused on providing water and sewer to its businesses and residents. We began a two-phase project, with Phase 1 started in FY 2021 and Phase 2 in 2022. Both phases will provide water to a total of 647 properties. The Port Salerno CRA used TIF funds for the water project to more quickly serve our residents and businesses.

Affordable Housing

Pettway Village Affordable Housing

A collaborative effort between Habitat for Humanity of Martin County and the Martin County CRA has culminated in Pettway Village. This new affordable housing community joins an older, established neighborhood in the Hobe Sound CRA. The CRA designed and constructed all the elements of a neighborhood; stormwater drainage systems, water distribution, sewer, roadway improvements, sidewalks, landscaping, on street parking and lighting; and Habitat will build 18 affordable single-family homes. The neighborhood even got a new road called SE Haston Way, named for an original family from the community. The construction has been funded completely with TIF dollars and has enjoyed strong and enthusiastic support from the community.

IN THE PIPELINE:

18 brand new, affordable homes for Martin County residents

Port Salerno **Affordable Housing**

Four affordable homes are to be built on eight county owned lots in the Port Salerno CRA. The county issued a Request for Proposal in July 2021. A selection committee was convened, and a contractor was chosen based on a set of criteria that included the concept, the financing plan and the experience of the respondent, among other things. Next steps include the signing of a development agreement and approval by the Board of County Commissioners.



2021

OCTOBER 2020 - Septic to Sewer Conversion (Rio CRA)

In collaboration with the Martin County Utilities Department's "Connect to Protect" program, 656 grinder stations are being installed throughout the Rio CRA area. **STATUS: UNDER CONSTRUCTION**

NOVEMBER 2020 – Neighborhood Enhancements (Jensen Beach CRA)

A total of twenty new trash receptacles were installed throughout downtown Jensen Beach. Neighborhood enhancements are those quality of life projects that downtowns, businesses and residents want to see happening in their communities. STATUS: COMPLETE



DECEMBER 2020

CRA staff presented an educational slide show including "CRA 101" and a discussion of Old Palm City projects to the Palm City Chamber of Commerce. The group was treated to holiday songs by the Hidden Oaks Middle School Choir and a visit by Santa and Mrs. Claus. It was a very festive celebration!



JANUARY 2021 - Master Stormwater Plan Update (Hobe Sound CRA)

An update of the 2006 Stormwater Report was begun. The final report was completed and accepted in August 2021 and it will be utilized as the basis for future projects in the Hobe Sound CRA. **STATUS: COMPLETE**



FEBRUARY 2021 - Church Street (Jensen Beach CRA)

Church Street is one of only three roadways that provide east to west connection in the Jensen Beach CRA. Staff is working with FP&L to underground the utilities and provide on street parking from Indian River Drive to Pineapple Avenue. **STATUS: IN DESIGN**



MARCH 2021 - Key Property Acquisition (Rio CRA)

The CRA acquired 1226 NE Dixie Highway and had the structures demolished. We hope to use this and other distressed properties for affordable housing. **STATUS: COMPLETE**



APRIL 2021 Martin County CRA

Martin County CRA staff spent the day visiting the Ft. Pierce CRA. We were warmly welcomed and treated to breakfast and a tour by Executive Director Shyanne Harnage and other staff members of the Ft. Pierce CRA. We learned about their amazing waterfront projects and saw some awesome redevelopment. We "Love the Fort!"

MAY 2021 - Park Drive/Seaward Avenue (Port Salerno CRA)

JUNE 2021 - Cassidy Center Parking Enhancement (Golden Gate CRA)

In partnership with the Martin County Parks and Recreation Department, the CRA designed the enlarged parking area at the Cassidy Center in Lamar Howard Park. This project increased the parking spaces from 8 to 38, installed lighting, landscaping and connected the community center to neighborhood streets on both the north and south sides. **STATUS: COMPLETE**

JULY 2021 - Dixie Highway Roadway Enhancement (Golden Gate CRA)

This stretch of Dixie Highway in the Golden Gate CRA is a four lane roadway with no bike lanes, no pedestrian lighting and only two crosswalks. The addition of a median with five pedestrian refuges, new lighting, signage, bike lanes and landscaping will increase walkability and safety for this pedestrian and bike friendly neighborhood. **STATUS: UNDER CONSTRUCTION**

AUGUST 2021 - El Camino Trail (Golden Gate CRA)

This project has received two Florida Department of Environmental Protection grants for construction. Elements of the project will include a multipurpose trail, pavilion, picnic facilities, Wi-Fi, community garden, edible orchard, exercise equipment, revamped soccer field, lighting and landscaping. STATUS: 100% DESIGN

SEPTEMBER 2021 - Indian Street Sidewalk (Golden Gate CRA)

A new sidewalk connection was constructed on a main neighborhood street, including the addition of two new crosswalks and signage to increase pedestrian and vehicular safety. **STATUS: COMPLETE**






· Picnic Areas

Design continued on both streets including a modification to raise the road to accommodate shoreline resilience and mitigate flooding. The Park Drive design includes 14 new parking spaces, sidewalk connection to the neighborhood, increased pedestrian and vehicular safety, lighting and landscaping. Seaward Avenue will include sewer installation, a full Traditional Neighborhood Design and a designated right turn lane onto Dixie Highway to increase vehicular safety and flow. **STATUS: IN DESIGN**
