

## Martin County community update: May 8, 2020

### RECENT UPDATES

#### \*Updated\* Beaches:

In our continuing effort to protect the health and safety of Martin County residents, today the Board made additional changes to beach access at Martin County-owned and managed beaches, with the exception of Hobe Sound Beach which remains closed. The Board is restricting beach access to Martin County residents, effective Saturday, May 9, until further notice. Seasonal residents must have documentation with their local address. As a reminder, Bathtub Beach remains closed due to erosion issues.

#### \*Updated\* County parks:

The board has relaxed restrictions for recreational activities at county-owned facilities. Pavilions, public restrooms, playgrounds, batting cages and racquet sport courts are open. In addition, the splash pad at Indian RiverSide Park is now open.

Use of trails, pathways, boardwalks, fishing piers and open areas is permitted, however no organized group sports are permitted. Lap swimming is allowed at Sailfish Splash Waterpark. Phipps Park Campground remains open and is not accepting any new reservations.

Social distancing and group size restrictions at all Martin County parks and facilities, as recommended by the Centers for Disease Control and Prevention, are required.

#### \*New\* Testing in Indiantown:

Florida Community Health Centers, Inc. (FCHC) is working in partnership with Martin County Emergency Management, the Florida Department of Health in Martin County and Cleveland Clinic Martin Health to provide expanded access to free COVID-19 testing for the residents of Indiantown. All Indiantown residents are eligible for testing and no symptoms are required.

Beginning Monday, May 11, drive-thru and walk-up testing will be offered at the FCHC location at 15858 SW Warfield Blvd.in Indiantown. Testing is available Monday through Friday from 9:00 a.m. to 6:00 p.m. Call 772-597-3596 for more information or to register.

#### \*Updated\* Increased options for public comment at BOCC meetings:

The Martin County Board of County Commissioners continues to hold board meetings at the Blake Library to comply with CDC guidelines for social distancing. Meetings are open to the public and the Board has established two ways to allow members of the public to provide comment remotely. These procedures will remain in place until the local state of emergency has expired. Details are listed below:

- Call 772-221-1463
- Commenters are asked to leave their name, phone number, meeting date and agenda item number for which they'd like to provide comment, and also to indicate if there are additional comments for general public comment periods at the beginning and/or end of the meeting.
- On the specified date, a county staff member will call the commenter back during public comment time. There is no set time for the comment periods to begin, so commenters may be called at any time during the meeting, which begins at 9:00 a.m.
- Registration for a public comment call will be accepted until 8:45 a.m. the day of the meeting.
- Commenters will be given three minutes to provide verbal comment to the board.
- Commenters will be allowed to provide comment on each item only once, whether comments are in person, written or over the phone.

- Commenters simply provide their name, the item they wish to comment on, enter up to 5,000 characters of text and then click submit.
- Once received, staff will review the comments to make sure they don't violate county policy.
- During the meeting, county staff will read the message into the record, but will be limited to three minutes per the county's established public comment procedure.
- Comments for an item must be submitted prior to the end of the public comment period for that item to be read into the record.

#### \*New\* Economic Injury Disaster Loans available for agricultural producers:

Agricultural producers impacted by the COVID-19 pandemic are now eligible for the U.S. Small Business Administration's Injury Disaster Loan (EIDL) and EIDL Advance programs. For more information, visit the <u>SBA website</u>.

#### \*New\* Pandemic Unemployment Assistance:

The federal Pandemic Unemployment Assistance (PUA) program provides unemployment benefits to those that may not otherwise be eligible under Florida's state Reemployment Assistance program, including independent contractors and individuals who are self-employed. Individuals who have been impacted by COVID-19 and believe they may be eligible for PUA can visit <u>www.FloridaJobs.org</u> and select "File a Claim" to apply and be considered for PUA.

#### \*Updated\* CARES Act economic impact payments:

Millions of Americans have already received their economic impact payments authorized by the Coronavirus Aid, Relief and Economic Security Act, also known as the CARES Act. The Internal Revenue Service continues to calculate and automatically send the payments to most individuals, however some may have to provide additional information to get their payments. #### \*Updated\* Reemployment assistance:

DEO will be conducting nightly maintenance to the CONNECT system to process claims and payments. CONNECT will be available from 8 a.m. to 7:59 p.m. daily. This schedule does not affect individuals that wish to file a new claim. Individuals can file a new claim 24 hours a day, 7 days a week at www.FloridaJobs.org.

# COUNTY INFORMATION Special BOCC meeting:

The next special meeting of the Martin County Board of County Commissioners is scheduled for Friday, May 15 at 9 a.m. in the John F. and Rita M. Armstrong Wing of the Blake Library. Meetings are open to the public and available on MCTV, Comcast Channel 20 and U-verse Channel 99. Meetings are also streamed on our website at <u>www.martin.fl.us</u> and on Martin County's Facebook and YouTube pages.

#### **Building closures:**

All county buildings and constitutional offices (Tax Collector, Clerk and Comptroller, Supervisor of Elections and Property Appraiser) are closed to walk-in traffic but still providing service to the public. Note: The Robert Morgade Library is closed for maintenance until further notice.

#### **Boat ramps:**

All restrictions for Martin County-owned boat ramps have been lifted as of May 1, 2020. The restriction by the Florida Fish and Wildlife Conservation Commission that recreational vessels shall have no more than 10 people on board and maintain a 50-foot distance between each vessel is still in effect.

#### **School District:**

All Florida school districts will remain closed for the remainder of the 2019-2020 academic year. All Martin County School District and school-related events, programs, athletic events and activities have been canceled for the same time period, with the exception of high school graduation ceremonies. The district continues to collaborate with health and safety experts to tentatively plan traditional graduation ceremonies in late July. More information will be released as it becomes available. #### STATE ACTIONS

#### Governor DeSantis reopening plan:

On Wednesday, April 29, Governor Ron DeSantis released his "Safe. Smart. Step-by-Step. Plan for Florida's Recovery" which outlines a phased approach to reopening.

Highlights of Phase 1 include:

- Schools continue with distance learning
- Visits to senior living facilities are prohibited
- Elective surgeries statewide can resume
- Restaurants may offer outdoor seating with six-foot space between tables and indoor seating at 25% capacity
- Retail can operate at 25% of indoor capacity
- No change for bars or gyms
- Vulnerable individuals should avoid close contact with people outside of their home

#### TESTING

#### **Cleveland Clinic Martin Health:**

Cleveland Clinic Martin Health is performing drive-thru testing for COVID-19 by appointment only at Martin North Hospital, 200 SE Hospital Avenue in Stuart, and Tradition Hospital, 10000 SW Innovation Way in Port St. Lucie. Anyone over the age of 16 who has a fever and respiratory illness (such as cough, runny nose, sneezing) or any patient with a fever and gastrointestinal illness (such as diarrhea, vomiting) is eligible for testing. For an appointment, individuals must call 772-419-3360, between 8 a.m. – 5 p.m., Monday – Friday and 8 a.m. – 3 p.m., Saturday and Sunday. Testing hours for both locations are from 9 a.m. – 3 p.m., Monday – Friday and 9 a.m. – 1 p.m., Saturday and Sunday. For additional information, visit www.martinhealth.org.

#### PREVENTION REMINDERS
