Information & Rules

- Rentals are from 9 a.m. to 6 p.m.
- Pavilions must be reserved by phone Monday-Friday 8 a.m. - 5 p.m.
- First come, first served basis.
- Pavilion permit and waivers must be electronically signed prior to the rental date in order to complete reservation.
- 100% payment due at time of booking.
- Martin County has a "No Balloons" policy at parks, including pavilions, due to the harmful effects of balloons on sea turtles and other wildlife in and around our facilities.
- No personal grills are permitted.
- No glass containers.
- No staking of portable structures into the ground is permitted.
- No bounce-houses, water slides, or any other inflatable structures are permitted.
- Cancellation policy—must cancel prior to 30 days of the rental date. Processing fee of \$25 for cancellations.
