Field trip slots are limited and fill up quickly. ALL CAMPS ARE REQUIRED TO REQUEST 2 WEEKS IN ADVANCE.

You may purchase tickets over the phone with a credit card or at the admissions window on the day of your field trip.

Purchase of 25-99 tickets: Child- \$11.86 Adult- \$13.56 (15% discount)

Purchase of 100+ tickets: Child- \$10.46 Adult- \$11.96 (25% discount)

IMPORTANT WATERPARK POLICIES

There are *no refunds*, including days with inclement weather.

There is a 1:10 counselor to camper ratio. You will not be permitted to enter the waterpark if this requirement is not met.

One (1) FREE counselor is permitted for every ten (10) paid campers.

Included in the Summer Camp Reservation Request is a copy of the Sailfish Splash Waterpark Rules and Regulations that you must sign and return with your Reservation Request form. Please go over this document with counselors prior to your visit to Sailfish Splash. If you have any questions, please contact our management team.

*Tax Exempt- Any camp claiming a tax-exempt status must provide proof (Tax Exempt Certificate) at the time of payment. If your camp is paying via check or credit card, the name on the check or credit card must match the name on the tax-exempt certificate. If the names do not match, a 6.5% sales tax will be applied to your total.

2020 Rules and Regulations

Welcome to Sailfish Splash Waterpark. For the safety of your camp, we would like to go over a few of our rules.

- A mandatory 1:10 counselor to camper ratio is required throughout the park. This means that your counselors are required to get in the water with your campers. In order to properly supervise your children, we ask that each counselor keep the 10 children they are responsible for within their arms reach.
- **If there is anyone that cannot swim, life jackets are available at no charge.** Please have the camper wear a life vest while in the Lazy River or Splash Playground area as needed. Life vests cannot be worn on the water slides. Non-swimmers are prohibited from using the diving boards, even with the life vests on.
- **Only US Coast Guard approved flotation devices are permitted in the park.** This means water wings, non-approved flotation devices, water toys, full face masks, snorkel masks, and snorkels are prohibited.
- **You must be 42 inches or taller to ride the waterslides.** No sunglasses, goggles, or water shoes are allowed on the slides, and you must be in appropriate swim attire. No denim or cotton clothing will be allowed down the slides. Your attire must be a bathing suit or dry-fit material.
- Campers may not access the Learn to Swim or Competition pools. The diving boards may be open throughout the day based on programming needs. Anyone wishing to use the diving boards must pass a swim test prior to using the boards.
- **Running is not allowed anywhere in the facility.**
- **ALL CAMPERS ARE REQUIRED TO BE WITHIN ARMS REACH OF A COUNSELOR AT ALL TIMES WHILE IN THE FACILITY.**
- We recommend that your campers keep their camp shirts on at all times while in the facility, unless they are going down the slides. Please ensure camper shirts are the appropriate size. It is unsafe to be in the water while wearing a shirt that is too large.
- **The use of whistles is strictly prohibited**
- **Please remind your campers that if they get lost, to find a lifeguard immediately. The lifeguards will be dressed in grey or teal shirts and royal blue shorts.**
- Please be sure to dispose of any waste in the trash receptacles and be sure that the bleacher area assigned to your camp is clean before you leave.
- **For your safety, please obey the lifeguards at ALL TIMES.**
- **Always listen for announcements**
- **If the lightning detector alarm goes off, please exit the water immediately and follow the direction of the waterpark staff.**
- **Camp buses must remain near the waterpark. In the case of inclement weather, all camps will need to get back on their bus.**

Sailfish Splash Staff are not a substitute for your counselors. While at the waterpark, it is the camp counselor's responsibility to enforce all waterpark rules and maintain the discipline of their campers.
