### SR 714/SW Martin Highway Widening Project in Martin County

The Florida Department of Transportation (FDOT), District Four, will host a Virtual Public Meeting and an In-person Construction Open House for the SR 714/SW Martin Highway widening project on **Thursday, July 29, 2021**. The Virtual Public Meeting will take place from 5:00 p.m. to 6:00 p.m., with the In-person Construction Open House to follow from 6:00 p.m. to 7:00 p.m. Please see below for detailed meeting information.

Construction Cost: \$21,345,976

Construction Start: July 22, 2021

Anticipated Completion: Fall 2024

### PROJECT IMPROVEMENTS

- Widen SR 714/SW Martin Highway from a two-lane undivided rural roadway to a four-lane divided urban roadway
- Widen the bridge over Florida's Turnpike
- Construct seven-foot buffered bike lanes and six-foot sidewalks on both sides of the roadway
- Realign SW Leighton Farm Avenue further west to line up with SW Deggeller Court and create a four-legged intersection
- Install a new closed-drainage system with a retention pond
- Install signing, signalization, and lighting upgrades

### TRAFFIC IMPACTS

Work will occur in phases to minimize impacts to the public. Lane closures along SR 714 and side streets are permitted from 9:00 a.m. to 4:00 p.m. and 7:00 p.m. to 6:00 a.m. On the Turnpike, nighttime lane closures are permitted Sunday night from 10:00 p.m. to 5:00 a.m., and Monday through Thursday night from 9:00 p.m. to 5:00 a.m. Nighttime full closures will occur on the Florida's Turnpike Sunday through Thursday night from 10:30 p.m. to 5:30 a.m. to facilitate the bridge widening work. During this time, Turnpike traffic will be detoured at Indiantown Road and Becker Road to I-95. Advance notice will be provided and detour signage will be in place.
