☐ A letter with the following information shall be provided.

- The name and address of the individual or sponsor of the proposed display and date and time of display.
- The name and address of the individual and/or company contracted to actually discharge the fireworks.
- A copy of the applicable State or Federal License or Permits.
- A description setting for the age, experience and physical characteristics of the person or persons actually discharging the fireworks.
- The number, size and type of fireworks to be discharged.
- The manner and place of storage of fireworks prior to the display.
- □ A site plan showing distance of all buildings, highways, any overhead obstruction and shall indicate the point at which fireworks will be discharged as well as showing all setbacks in accordance with NFPA 1123, 2010 Edition.
   □ Evidence of financial responsibility by providing a Bond or Certificate of Insurance for the minimum amount of \$500,000 bodily injury and \$100,000 property damage.
   □ Indemnification Agreement holding the County harmless from any and all liability which may be caused to any person or property if the display is held on any County Property or facility
   □ A letter of "no objection" from the Martin County Sheriff's Office and the Martin County Airport.

#### Flow Test \$200.00 per hydrant:

The flow will be completed within 2 to 3 days upon receipt of all the above items.

- ☐ A written request for a water flow including the number of hydrants to be flowed, a contact name as well as a telephone number and an email address.
- ☐ A map of the site indicating the hydrant and a secondary hydrant is required to the testing.

\*\*\*If an inspection is scheduled after normal business hours (8:00 -4:30 Monday through Friday) or anytime Saturday or Sunday, Additional fees will apply.
